ORDER

M/s. Kwaliti Pharmaceuticals Pvt. Ltd., 6th Mile Stone, Village- Nag Kalan Majitha Road, Amritsar, Punjab - 143601 was placed with orders to supply Inj. Rabeprazole Sodium 20mg vide purchase order No. CR15295 dtd.15.09.2015, No. CR15801 dtd.08.02.2016 & No. CR15948 dtd.22.03.2016. The firm supplied the said drug in a number of batches out of which four batches have been declared as "Not of Standard Quality" (NSQ) by the Govt. Analyst, State Drug Testing & Research Laboratory, Odisha, Bhubaneswar. The details of batches of subject drug and the reason for declaring NSQ are mentioned below.

In view of the above M/s. Kwaliti Pharmaceuticals Pvt. Ltd. was issued Show Cause Notice vide this office letter No.5195 dtd.24.05.2017 seeking explanation within seven days of receipt of the letter as to why it shall not be blacklisted for a period of three (03) successive years for supplying Inj. Rabeprazole Sodium 20mg in pursuance to PO Clause No. 6(g)(ii) read with PO Clause No. 6(e) and Bid Condition No. 6.39.8.1(ii) read with condition No. 6.31.7 of Bid Reference No. OSMCL/2015-16/DRUGS-DHS-CAT-III/04.

The noticee-firm has failed to furnish any reply to the Show Cause, as required under this office letter dtd.24.05.2017 received on 31.05.2017 as per the record of India Post. Therefore, as per terms and conditions of PO Clause No. 6(g)(ii) read with PO Clause No. 6(e) and Bid Condition No. 6.39.8.1(ii) of Bid Reference No. OSMCL/2015-16/DRUGS-DHS-CAT-III/04, M/s. Kwaliti Pharmaceuticals Pvt. Ltd. is hereby blacklisted for the item Inj. Rabeprazole Sodium 20mg for a period of three (03) successive years from the date of issue of this order.
