**ORDER**

In pursuance of Odisha State Medical Corporation Ltd. Purchase Order No. CR15330 dt.14.12.2015, M/s. Bubuna Chemicals, Jagatpur, Cuttack had supplied 216000 tablets of Ibuprofen 400mg (film coated) to warehouses of Nayagarh, Sonepur and Gajapati Districts. The firm supplied **Ibuprofen Tablet 400mg.** having Batch no. **K-0215, Mfg. Dt.12/2015 and Expiry Dt.11/2017.** On test and analysis, the drug was found to be **Not of Standard Quality.** Accordingly the firm was served with a show cause notice vide this office letter no.4808 dt.21.05.2016. In reply to show cause notice the firm furnished its reply vide their letter dt.24.05.2016. It was also observed that the firm supplied tablets of different shapes having same batch no. On visual examination, the printing of batch no., mfg. date., exp. date appears to have been manipulated. The matter was referred to a committee of General Managers, who have gone into details and opined that the firm has not only supplied **Not of Standard Quality** drugs but also indulged in fraudulent practice. The reply of the firm in this matter was held to be devoid of merit. Earlier the firm was blacklisted for **Diclofenac Tab. 50mg.** vide this office order no.2138 dt.27.02.2016. The primary mandate of OSMCL is to procure and distribute quality drugs in the health facilities of the state. Allowing fraudulent practice amounts to compromising with the quality of drug. Therefore the firm is blacklisted for such supply of poor quality drugs as well as adopting fraudulent practice for Ibuprofen Tab. 400mg.

As the firm is blacklisted for two items i.e. Tab. Ibuprofen 400mg and Tab. Diclofenac 50mg, in accordance with Procurement Guideline Clause 6.1 (ii) of OSMCL, M/s. **Bubuna Chemicals, Jagatpur, Cuttack** is hereby blacklisted. They shall not be allowed to supply any drug to Odisha State Medical Corporation for a period of three (3) successive years from the date of issue of this order.

The performance security/bank guarantee/EMD if any deposited by the firm for **Tab. Ibuprofen 400mg** is hereby forfeited.
