The provisional list of candidates shortlisted for the posts of Accountant, Assistant (HR & Admn.) and Jr. Assistant (MD's Secretariat), Sr. Pharmacist-Warehouse, Jr. Pharmacist-Warehouse, Sr. Pharmacist-Quality Assurance and Jr. Pharmacist- Quality Assurance were published inviting objections from the candidates and submission of wanting documents. On consideration of the objections submitted by the candidates and compliances given, the final list of candidates for the posts of **Sr. Pharmacist-Warehouse, Jr. Pharmacist-Warehouse, Sr. Pharmacist-Quality Assurance and Jr. Pharmacist- Quality Assurance** who had applied for the aforesaid posts eligible for Computer Based Recruitment (written) Test (CBRT) is hereby published and uploaded in the Odisha State Medical Corporation Ltd. website www.osmcl.nic.in.

The selection process for the posts of Accountant, Assistant (HR & Admn.) and Jr. Assistant (MD's Secretariat) is hereby annulled due to non-availability of sufficient numbers of eligible candidates.

Issue of Admit Card for the Computer Based Recruitment Test :

1. Online Admit Cards will be available from **02.10.2015** and can be downloaded from OSMC web site www.osmcl.nic.in by clicking on the link given.
2. Candidates have to use the last 6 digits of their application id (for example if the application ID is OSMC_OSM_003588, the user ID will be **003588**). Password will be the Date of Birth in DDMMYY format (eight digits) without any special character. For example, if the Date of Birth is 1st July 1984, then the password will be 01071984
3. Candidates are advised to verify the details given in the Admit Card and discrepancies, if any may be pointed out in the email address rec.osmcl@nic.in.
4. Candidates are further advised to read the information / instructions contained in the Admit Card.
5. In case of any problem in downloading the Admit Cards, please contact us in the email address rec.osmcl@nic.in.
6. Production of Admit Card is a mandatory requirement, without which candidate shall not be allowed to enter into the examination centre.

Computer Based Recruitment (Written) Test :

7. Candidates who fail to report on the date and time indicated in the Admit Card shall not be allowed to appear in the Computer Based Recruitment Test. No extension of time, change of date or time slot shall be entertained.
8. There will be different Computer Based Written Tests for different posts.
9. Care is being taken to ensure that candidates who have applied for multiple posts will be accommodated in the same examination centre.
10. There will be a mock test module which can be used by the candidates to familiarize themselves in Computer Based Written Test. The mock test module will be available in the Odisha State Medical Corporation Ltd. web site www.osmcl.nic.in from 02.10.2015. Please click on the appropriate link for taking mock test.
11. The Computer Based Written Test shall be of 90 minutes duration.
12. There will be 100 nos. of Multiple Choice Questions, each question carrying one mark each. There will be no negative marking.
13. The CBRT will assess the subject knowledge and general aptitude. Subject knowledge will include both theoretical aspects as well as questions related to the post advertised as per TOR.
14. General aptitude test will comprise of general knowledge, English, current affairs, quantitative aptitude, reasoning ability, fundamental knowledge of computer etc.
15. Result of the Computer Based Written Test will be published on the same day in the web site of the Corporation www.osmcl.nic.in. Candidates who qualify in the Computer Based Written Test will be intimated through email and sms. Hence candidates are requested to periodically check their email and message inbox for the result of the CBRT.
16. Based on merit three times the number of candidates for the posts (category-wise) will be called for Personal Interview. Venue of the Interview will be intimated through email and sms. Hence candidates are requested to check their email and message inbox for the result of the Computer Based Written Test.

C

Original Certificate Verification and Interview.

17. The original documents of the short listed candidates for the Personal Interview will be verified prior to the Interview.
18. Candidates who do not meet the eligibility criteria as per the TOR and eligibility criteria shall not be allowed for Interview.
19. The following **ORIGINAL** documents have to be produced at the time of document verification prior to the interview.
 - a) HSC certificate and Mark sheet
 - b) Original certificates of B.Pharma or D.Pharma as the case may be.
 - c) **Original (year-wise / semester-wise) mark sheets of the qualifying examination i.e. B.Pharma or D.Pharma as the case may be. Back paper mark sheets, if any must also be submitted in order to calculate the percentage of marks.**
 - d) Failure to produce all mark sheets of the qualifying examination will lead to forfeiture of the claim to appear in the Interview as the percentage of marks can not be calculated. Candidates who are found to have secured less than the prescribed percentage of marks will not be allowed for Interview.
 - e) Post-qualification relevant experience certificate/s for minimum 3 year duration in respect of the posts of Sr. Pharmacist-Warehouse and Sr. Pharmacist-Quality Assurance and 2 years of experience certificate/s in respect of the posts of Jr. Pharmacist-Warehouse and Jr. Pharmacist-Quality Assurance.
 - f) Experience will be counted up to **07.03.2015** for the posts of Sr. Pharmacist-Warehouse and Jr. Pharmacist-Warehouse and upto **09.03.2015** for the posts of Sr. Pharmacist-Quality Assurance and Jr. Pharmacist-Quality Assurance. i.e. the last date of submission of online application forms.
 - g) The period and nature of job responsibility should be clearly ascertained from the experience certificates. Offer / joining / resignation / promotion / confirmation / increment letters will not be accepted as the period of experience can not be ascertained from the said documents.
 - h) The experience period as mentioned in the application form should clearly be ascertained from the experience certificate. Hence the experience certificate must clearly mention the period (from.....to.....) and must bear the dated signature of the issuing authority and the date of issue.

- i) Post-qualification experience will be counted from the month of August of the relevant year, i.e. the start of the Academic session unless the candidate produces documentary evidence to the contrary.
- j) In case the candidate is presently working in an organization and cannot produce the experience of the current organization, **a certificate of the competent authority mentioning the period** from which she / he is working in the organisation and the nature of job responsibility has to be produced. It is to be noted that the total relevant experience of the candidate should be of minimum 3 years or 2 years as the case may be.
- k) Authentic document issued by the competent authority indicating **conversion from grade to percentage** for those who have obtained marks under grade system.
- l) Caste certificate, in case of SC / ST / SEBC candidates. **In case the candidate fails to produce Caste Certificate she / he shall be treated as a general candidate.**
- m) Up to date Registration Certificate from Odisha Pharmacy Council.
- n) Disability certificate in case of candidates belonging to PWD category. **Please take note that successful candidates in the PWD category shall be referred to the medical board for assessing the percentage of disability and suitability for the post.**
- o) Original Residence / nativity / domicile certificates issued by the competent authority
- p) Proof of having passed Odia up to 7th standard
- q) Two latest colour passport size photographs.
- r) Proof of identity like Voter Id card, PAN card. Driving license, Adhar card, Passport etc.

The candidates also must mandatorily bring with them one photo copy of the above mentioned documents.

20. Candidates are advised to refer to the information / instructions provided in the recruitment notice no.2116 / OSMC / HR / 2015 Dated. 07.09.2015 available in www.osmcl.nic.in.

21. It is to be noted that candidates who are found ineligible as per the eligibility criteria during Certificate Verification shall not be allowed for Interview.

22. Candidates who fail to produce any of the original documents as mentioned above shall not be allowed to appear in the Interview.

Performance of candidates will be assessed on the basis of work experience, subject knowledge, presentation / communication skill, general aptitude and understanding of critical issues related to the post / analytical ability etc. as against the TOR as per advertisement no. 2/OSMC/REC./HR/2015, Dated 18.02.2015 and 4/OSMC/REC./HR/2015, Dated 20.02.2015

24. Any instance of impersonation / malpractice during Computer Based Written Test, submission of forged / manipulated documents either at the time of submission of online application form or at the time of certificate verification shall be dealt with seriously. Such candidates shall be debarred from appearing in the examination / interview as the case may be and will also be liable for appropriate legal / criminal action as deemed proper.

25. Candidates should take care that if any evidence regarding the ineligibility of any candidate if detected at a later stage, shall lead to disqualification including cancellation of selection.

26. Any query relating to recruitment have to be made in the email address of the Corporation i.e. rec.osmcl@nic.in and shall be replied through email only. **No personal / telephonic communication regarding the recruitment will be entertained.** **Any canvassing and attempt by the candidate to influence the process of selection will lead to rejection of candidature.**

27. OSMC shall resort to verification of documents from the educational institutions and employer organizations directly as per requirement. Any act of fraudulent practice, if detected in future will be viewed adversely & legal action will be initiated.
28. No claim for any cost reimbursement for appearing in the CBRT and Interview shall be entertained. **Candidates must be prepared to stay back for the Interview in case they are shortlisted for the Personal Interview.**
