ORDER


Whereas M/s. Om Biomedic Pvt. Ltd. had been placed with order for supply of **Albendazole Oral Suspension I.P.** vide **Purchase Order No. CR15497 Dt.08/12/2015**. The firm supplied Albendazole Oral Suspension I.P. in thirty-eight (38) different batches, out of which Batch No. OBL-166, Mfg. Dt.10/2015, Exp. Dt.09/2017 & Batch No. OBL-248, Mfg. Dt.01/2016, Exp. Dt.12/2017 have been declared as **Not of Standard Quality** by two different empanelled NABL accredited laboratories. The same has been intimated to the supplier vide this office letter no.1924 dt.23/02/2016, letter no.3979 dt.07/04/2016 & letter no.6070 dt.04/07/2016.

Whereas since two batches of **Albendazole Oral Suspension I.P.** have been declared as **Not of Standard Quality**, the firm was issued with **show cause notice** requiring them to show cause as to why they shall not be blacklisted for supplying two batches of **Not of Standard Quality** drugs vide this office letter no.6070 dt.04/07/2016.

Whereas the supplier in his letter dt.13.07.2016 received through e-mail on 14.07.2016 requested for personal hearing and personal hearing was conducted in office chamber of Managing Director, OSMCL in which Shri Mohit Bhatia appeared on behalf of the supplier M/s. Om Biomedic Pvt. Ltd. and has submitted reply to show cause. After hearing the party and examining the documents it is seen that the supplier has no satisfactory explanation to offer. The samples have been duly tested and found to be **Not of Standard Quality** by two different laboratories. Quality of medicines cannot be compromised under any circumstances. Production of drugs in high quantity cannot be a justification for poor quality. Therefore in accordance with **Bid Reference No.OSMCL/2015-2016/DRUGS-DHS-Cat-IV/05** and **Purchase Order Clause No.6(g)(ii)**, the firm is hereby blacklisted/ debarred for supplying Albendazole Oral Suspension I.P. henceforth.

Whereas the firm M/s. Om Biomedic Pvt. Ltd. has earlier been blacklisted for supplying two batches of Amoxicillin Oral Suspension I.P. vide this office order no.4384 dt.22/04/2016. As such the firm is blacklisted for two(02) items i.e. Amoxicillin Oral Suspension I.P. and Albendazole Oral Suspension I.P. and therefore in accordance with **Clause No.6.39.8.2 of Bid Reference No.OSMCL/2015-2016/DRUGS-DHS-Cat-IV/05**, M/s. Om Biomedic Pvt. Ltd., Haridwar, Uttarakhand – 249403 is hereby blacklisted. They shall not be allowed to supply any drug to **Odisha State Medical Corporation** for a period of three(03) successive years from the date of issue of this order.

The Performance Security/ Bank Guarantee/ EMD submitted by the firm for the said item is hereby forfeited & the firm shall not be allowed to participate nor considered in the tenders of **Odisha State Medical Corporation Ltd.** All concerned be informed accordingly.
