Baddi, Solan, Himachal Pradesh – 173205, Email – [sbh@martinbrown.in](mailto:sbh@martinbrown.in) was placed with purchase orders CR27536 dtd. 28.09.2022 for the item **(D49002) Lactulose Solution (Palatable, with measuring cap and plastic container as per I.P), 10gm/15ml (3.335gm/5ml)**. The above mentioned purchase orders leads to non supply due to the firm has withdrawn the item and requested not to issue purchase orders for the said item. The mentioned drug item is very much essential in nature for needy patients getting treatment in Govt. Hospitals of the state under free Drugs scheme. The non supply of the above mentioned item resulted in non-availability & hindrance in public health services and treatment of patients.

In view of the above the firm **Ms. MARTIN AND BROWN BIO SCIENCES.**, Vill. Malkumajra, Opp. Anapurna Hotel, PO- Bhud, Teh. Baddi, Solan, Himachal Pradesh – 173205, Email – [sbh@martinbrown.in](mailto:sbh@martinbrown.in), was issued with a Show Cause Notice vide this office letter No. 2038 dtd. 22.03.2023 seeking explanation within three days from issuance of the above mentioned letter why OSMCL shall not derecognise/ debar the firm as a defaulting supplier for non execution of the supplies for a period of 3 years as per tender clause, vide Bid Ref. No. OSMCL/2022-23/DRUGS-DHS-GEN-RE-TENDER/12. However, the committee has gone through the replies given by the firm and analysed thoroughly and the reply of the firm was not satisfactory.
