The firm **Ms. LA-CHEMICO PVT. LTD.**, 66/1A, Baithakkhana Road, 1st Floor, Kolkata, West Bengal - 700009, Email - [lcplpharma@gmail.com](mailto:lcplpharma@gmail.com) was placed with purchase orders CR26603 dtd. 15.07.2022, CR26865 dtd. 06.08.2022 and CR28091 dtd. 06.12.2022 for the item **D17015 (Tab. Amlodipine Besylate(Aluminium foil/Blister pack), 5 mg/Tab)**. The above mentioned purchase orders leads to non supply after repeated communications. The mentioned drug item is very much essential in nature for needy patients getting treatment in Govt. Hospitals of the state under free Drugs scheme and the said drug item is also an essential programme item. The non supply of the above mentioned item resulted in non-availability & hindrance in public health services and treatment of patients.

In view of the above, the firm **Ms. LA-CHEMICO PVT. LTD.**, 66/1A, Baithakkhana Road, 1st Floor, Kolkata, West Bengal - 700009 was issued with Show Cause Notices vide this office letter No. 444 dtd. 18.01.2023 , 112 dtd. 05.01.2023 and 7794 dtd. 12.10.2022 seeking explanation within seven days from issuance of the above mentioned letters why OSMCL shall not derecognise/ debar the firm as a defaulting supplier for non execution of the supplies for a period of 3 years as per tender clause no. 6.39.1 vide Bid Ref. No. OSMCL-2022-23/DRUGS-DHS-GEN-GR-I/01. However, despite repeated communications to the firm, the reply of the firm for non supply of the **D17015 (Tab. Amlodipine Besylate(Aluminium foil/Blister pack), 5 mg/Tab) is not satisfactory**. The value of the non-executed purchase orders are mentioned below.
