AGOG PHARMA LTD.**, Plot No.-33, Sector II, The Vasai Taluka, Industrial Co-Op, Estate Ltd, Gauraipada, Vasai (E), Palgarh, Maharashtra - 401208, Email - agogpharma@rediffmail.com was placed with purchase orders CR26344 dtd. 18.06.2022, CR26723 dtd. 22.07.2022, CR27021 dtd. 25.08.2022, CR27609 dtd. 01.10.2022 and CR28329 dtd. 31.12.2022 for the item **D09020 (Tab. Ciprofloxacin HCl (Aluminium foil/Blister pack),500 mg/Tab) and purchase orders CR25900 dtd. 07.05.2022, CR27521 dtd. 28.09.2022 for the item D20005 (Tab. Spironolactone(Aluminium foil/Blister pack),25 mg/Tab)**. The above mentioned purchase orders leads to non supply after repeated communications. The mentioned drug item is very much essential in nature for needy patients getting treatment in Govt. Hospitals of the state under free Drugs scheme. The non supply of the above mentioned item resulted in non-availability & hindrance in public health services and treatment of patients.

In view of the above, the firm **M/s. AGOG PHARMA LTD.**, Plot No.-33, Sector II, The Vasai Taluka, Industrial Co-Op, Estate Ltd, Gauraipada, Vasai (E), Palgarh, Maharashtra - 401208) was issued with a Show Cause Notices vide this office letter No. 429 dtd. 18.01.2023 , 88 dtd. 05.01.2023 , 9918 dtd. 17.12.2022 and 9545 dtd. 03.12.2022, 8206 dtd. 29.10.2022 and 7824 dtd. 12.10.2022 seeking explanation within seven days from issuance of the above mentioned letters why OSMCL shall not derecognise/ debar the firm as a defaulting supplier for non execution of the supplies for a period of 3 years as per tender clause no. 6.39.1 vide Bid Ref. No. OSMCL-2022-23/DRUGS-DHS-GEN-GR-I/01. However, despite repeated communications to the firm, the firm has replied due to hike of Raw Material cost caused non supply of the item D20005 (Tab. Spironolactone 25 mg/Tab). The value of the non-executed purchase orders are mentioned below.
