JACKSON LABORATORIES P LTD.**, 22-24 Majitha Road, Bye Pass, Amritsar, Punjab - 143004, Email - info@jacksonlaboratories.com was placed with purchase orders CR26243 dtd. 09.06.2022, CR26580 dtd. 14.07.2022, CR26954 dtd. 22.08.2022, CR27766 dtd. 20.10.2022 and CR28080 dtd. 03.12.2022 for the item **D09026 (Tab. Cefadroxil (Aluminium foil/Blister pack),500 mg/Tab)**. The above mentioned purchase orders leads to non supply after repeated communications. The mentioned drug item is very much essential in nature for needy patients getting treatment in Govt. Hospitals of the state under free Drugs scheme. The non supply of the above mentioned item resulted in non-availability & hindrance in public health services and treatment of patients.

In view of the above, the firm **M /s. JACKSON LABORATORIES P LTD.**, 22-24 Majitha Road, Bye Pass, Amritsar, Punjab - 143004 was issued with a Show Cause Notices vide this office letter No. 441 dtd. 18.01.2023 , 106 dtd. 05.01.2023 , 9948 dtd. 17.12.2022 ,9527 dtd. 03.12.2022 and 7686 dtd. 12.10.2022 seeking explanation within seven days from issuance of the above mentioned letter why OSMCL shall not derecognise/ debar the firm as a defaulting supplier for non execution of the supplies for a period of 3 years as per tender clause no. 6.39.1 vide Bid Ref. No. OSMCL-2022-23/DRUGS-DHS-GEN-GR-I/01. However, despite repeated communications to the firm, the firm has replied due to Ukraine war there is non-availability of Raw material which lead to non supply.
