
M/s. Jackson Laboratories Pvt. Ltd., 22-24, Majitha Road Bye Pass, Amritsar - 143001, Punjab was placed with orders to supply Inj. Lignocaine Hydrochloride and Adrenaline Bitartrate (Lignocaine HCl 21.3mg/ml + Adrenaline 0.5mg/ml) (30ml vial) vide purchase order No. CR18879 Dtd.14.08.2018 & No. CR19047 Dtd.11.10.2018. The firm supplied the said drug in a number of batches out of which two (02) batches have been declared as "Not of Standard Quality" (NSQ) by all the three approved NABL accredited laboratories empanelled by OSMCL. The details of batches of subject drug and the reason for declaring NSQ are mentioned below.

Lignocaine Hydrochloride and Adrenaline Bitartrate BP (30ml vial) in pursuance to PO Clause No. 5(h)(ii) and Bid Condition No. 6.39.8.1(ii) of Bid Reference No. OSMCL/2017-18/DRUGS-DHS (Re-Tender-I)/11.


The noticee-firm has failed to furnish any reply to the Show Cause, as required under this office letter dtd.28.01.2019 received on 06.02.2019 as per the record of India Post. Ltd., 22-24, Majitha Road Bye Pass, Amritsar - 143001, Punjab is hereby derecognised/blacklisted for the item Inj. Lignocaine Hydrochloride and Adrenaline Bitartrate (Lignocaine HCl 21.3mg/ml + Adrenaline 0.5mg/ml) (30ml vial) for a period of three (03) successive years from the date of issue of this order.
