## ORDER


M/s. Adroit Pharmaceuticals Pvt. Ltd., 46, Garoba Maidan, Nagpur – 440008, Maharashtra was placed with orders to supply Syp. Ferrous Sulphate + Folic Acid 100ml vide purchase order No. CR17497 dtd.04.10.2017. The firm supplied the said drug in a number of batches out of which seven batches have been declared as “Not of Standard Quality” (NSQ) by majority of the status report (out of three empanelled approved NABL accredited labs). The details of batches of subject drug and the reason for declaring NSQ are mentioned below.

In view of the above M/s. Adroit Pharmaceuticals Pvt. Ltd. was issued Show Cause Notice vide this office letter No.5138 dtd.06.04.2018 seeking explanation within seven days of receipt of the letter as to why it shall not be blacklisted for a period of three (03) successive years for supplying Syp. Ferrous Sulphate + Folic Acid 100ml in pursuance to PO Clause No. 5(h)(ii) read with Bid Condition No.6.39.8.1(ii) of Bid Reference No. OSMCL/2016-17/DRUGS-DHS-GR/01.

The noticee-firm has failed to furnish any reply to the Show Cause, as required under this office letter dtd.06.04.2018 received on 09.04.2018 as per the record of India Post. Therefore, as per terms and conditions of PO Clause No. 5(h)(ii) read with Bid Condition No. 6.39.8.1(ii) of Bid Reference No. OSMCL/2016-17/DRUGS-DHS-GR/01, M/s. Adroit Pharmaceuticals Pvt. Ltd. is hereby debarred to supply and participate in the tender process of OSMCL for the item Syp. Ferrous Sulphate + Folic Acid 100ml for a period of three (03) successive years from the date of issue of this order.


