Meropenem (with 10ml diluents in plastic container),1gm** and purchase orders CR25410 dtd. 14.02.2022, CR24046 dtd. 14.09.2021, CR24722 dtd. 22.11.2021, CR25241 dtd. 28.01.2022 for the item **D09091 Tab. Cefixime (Disp. Tab./ Film Coated) (Aluminium Foil/Blister pack),200mg/Tab.** The above mentioned purchase orders leads to non supply after repeated communications. The mentioned drug item is very much essential in nature for needy patients getting treatment in Govt. Hospitals of the state under free Drugs scheme. The non supply of the above mentioned item resulted in non-availability & hindrance in public health services and treatment of patients.

In view of the above the firm Ms. MARC LABORATORIES LTD, Avanbai Mansions, 3, Vidhan Sabha Marg, Lucknow (UP) – 226001 was issued with a Show Cause Notice vide this office letter No. 6012 dtd. 22.08.2022 and letter No. 4077 dtd. 09.06.2022 seeking explanation within seven days from issuance of the above mentioned letter why OSMCL shall not derecognise/ debar the firm as a defaulting supplier for non execution of the supplies for a period of 3 years as per tender clause no. 6.39.1 vide Bid Ref. No. OSMCL/2021-22/DRUGS-DHS-GEN-GR-II/02 and OSMCL/2021-22/DRUGS-DHS-GEN-GR-I/01. However, the committee has gone through the replies given by the firm and analysed thoroughly.


