But the firm has failed to submit the agreement and performance security as per tender declaration format T3 submitted by the firm. The non supply of the above mentioned item resulted in non-availability & hindrance in public health services and treatment of patients.

No. **OSMCL/2021-22/DRUGS-DHS-GEN-GR-I/01** and the decision taken in the meeting held on dtd. 21.02.2022. However, the committee has gone through the replies given by the firm and analysed thoroughly and decided to **Black list/debar the firm** for a period of **one year (1 year)** from the date of opening of technical Bid i.e from Dt. 13.01.2022 to Dt. 12.01.2023.
