Bidder has not submitted the impact test, bend test, salt spray chamber test & epoxy powder coating test report from any Govt. or NABL approved lab accredited as per ISO 17025 for quoted item as Per Bid Requirement.3. Bidder has not submitted the product data sheet / brochure for the quoted model, hence technical evaluation could not be verified.4. As per submitted (Format-T9), submitted Proof of Past supply PO copies of INSTRUMENT TROLLEY WITH RAILING are from private institutions instead from Central / State Govt. Organization / PSU /Public Listed Company against the bid requirement of 190 nos. Hence Committee recommended to not qualifying the Bidder.
2.	M/s. Midmark India Private Limited	<ol style="list-style-type: none">1. Bidder has not submitted the impact test, bend test, salt spray chamber test, & epoxy powder coating test report from any Govt. or NABL approved lab accredited as per ISO 17025 for quoted item as Per Bid Requirement.
3.	M/s. Medico International	<ol style="list-style-type: none">1. The quoted model i: e AS-162 of the footstep is not mentioned in the submitted CE certificate.
4.	M/s. Narayan Industries	<ol style="list-style-type: none">1. The submitted salt spray test & epoxy powder coating test which is non govt. or NABL accredited laboratory as per Bid Requirement.2. As per (Format-T9), Submitted Proof of Past supply PO copies of 10 Nos. of Foot Steps & 100 Nos. of Crash Cart Trolleys (From Central / State Govt. Organization / PSU /Public Listed Company) which in totality works out to 110 Nos. against the bid requirement of 190 nos. The PO Copies of other furniture are from private institutions, hence not accepted by the committee.

5.	M/s. Nilkamal Limited	<ol style="list-style-type: none"> 1. The quoted model i: e FOOT STEP is not mentioned in the submitted CE certificate. 2. Bidder has not submitted the epoxy powder coating test reports from any Govt. or NABL approved lab accredited as per ISO 17025 for quoted item as Per Bid Requirement. 3. Bidder has not submitted the parawise / point wise compliance to technical specification in format T11, Hence the technical parameter could not be verified.
6.	M/s. POCT Services	<ol style="list-style-type: none"> 1. Bidder has not submitted the bend test reports from any Govt. or NABL approved lab accredited as per ISO 17025 for quoted item as Per Bid Requirement.
7.	M/s. Riya Fibro Tech	<ol style="list-style-type: none"> 1. Bidder has not Submitted hard copy of EMD & Bid cost. Hence committee recommended to not qualifying the bidder.
