M/s. La-Chemico Pvt. Ltd., 66/1A, Baithakkhana Road, 1st Floor, Kolkata-700009 was placed with orders to supply **Tab. Zinc Sulphate (Dispersible Tablets) equivalent to 20mg of elemental Zinc** vide **Purchase Order No. CR24147 Dtd. 21.09.2021**. The firm supplied the drug in number of batches, out of which four (04) number of batches have been declared as **"Not of Standard Quality (NSQ)"** by the **Govt. Analyst CDL, Kolkata**, which have been communicated to the supplier with enclosed copies of test reports vide this office letter no. 5689 Dtd. 05.08.2022 and 6260 Dtd. 30.08.2022 under intimation to the Drug Licensing & Controlling Authority, the Directorate of Drugs Control, P-16, India Exchange Place Extension, K.I.T Building- 5th Floor, Kolkata-700073, India.

In view of the above M/s. La-Chemico Pvt. Ltd., was issued with Show Cause Notice (SCN) vide this office Letter No. 6562, Dt. 12/09/2022 seeking explanation within seven (07) days of receipt of the letter as to why it shall not be de-recognised / de-barred for the item **Tab. Zinc Sulphate (Dispersible Tablets) equivalent to 20mg of elemental Zinc** as per PO Clause No. 5(h) (ii) read with Bid Condition No. 6.38.1 (ii) of Bid reference No. OSMCL/2021-22/DRUGS-DHS-GEN-GR-I/01.

The noticee firm has failed to furnish any reply to the Show Cause Notice (SCN) within the stipulated time period as required under this office letter no. 6562 Dtd. 12.09.2022 received by the firm on Dtd. 13.09.2022 through mail.

Hence, as per terms and conditions of PO Clause No. 5(h) (ii) read with Bid Clause No. 6.38.1(ii) of Bid Reference No. OSMCL/2021-22/DRUGS-DHS-GEN-GR-I/01, **Ms. La-Chemico Pvt. Ltd.**, Kolkata 66/1A, Baithakkhana Road, 1st Floor, Kolkata-700009 is hereby, de-recognised /de-barred for the item **Tab. Zinc Sulphate (Dispersible Tablets) equivalent to 20mg of elemental Zinc** for a period of three (03) successive years from the date of issue of this order.



The Performance Security / Bank Guarantee / EMD amount submitted by the firm for the said item is hereby, forfeited & the firm shall not be allowed to participate in the tender process of Odisha State Medical Corporation Ltd. (OSMCL) for the above said item.
