ORDER

M/s. Pushkar Pharma, Bhandariwala, Kheri, Kala-Amb, Sirmour – 173 030 (H.P.) was placed with orders to supply Methylcobalamine Inj. 1500 mcg/amp vide Purchase Order No. CR19865 Dt.27.05.2019 of Bid Ref. No. OSMCL/2018-19/DRUGS-DHS-GEN/04 and rate contract valid till 17 Jan 2020. The firm supplied the drug in a number of batches, out of which three (03) number of batches were declared as "Not of Standard Quality" (NSQ), on the basis of test reports received from the empanelled laboratories of OSMCL in terms of PO Clause No.5(d). Enclosing the copies of test reports, the result of the test reports was communicated to the supplier vide this office letter No. 560 dtd.14.01.2020 & No.1976 dt.17.02.2020.

The details of batches of subject drug and the reason for declaring the said batches as NSQ are mentioned below.

In view of the above, M/s. Pushkar Pharma was issued with Show Cause Notice (SCN) vide this office letter No. 2310 dtd.25.02.2020 seeking explanation within seven (07) days of receipt of the letter as to why it shall not be derecognised/ debarred for the item Methylcobalamine Inj. 1500 mcg/amp as per PO Clause No. 5(h)(ii) read with Clause No.6.39.1(ii) of Bid Reference No. OSMCL/2018-19/DRUGS-DHS-GEN/04.

In response to the SCN, the supplier vide his letter dtd.16.03.2020 have expressed their readiness to replace the subject batches, which is not acceptable.

Therefore, as per PO Clause No. 5(h)(ii) read with Clause No.6.39.1(ii) of Bid Ref. No. OSMCL/2018-19/DRUGS-DHS-GEN/04, M/s. Pushkar Pharma, Bhandariwala, Kheri, Kala-Amb, Sirmour (HP) – 173 030 is hereby derecognised/debarred for the item Methylcobalamine Inj. 1500 mcg/amp for three (03) years from the date of issue of this order.
