Order. 2138 / OSMC / Dated. 27.02.2016

ORDER

M/s. Bubuna Chemicals, D-2/2, New Industrial Estate, Jagatpur – 754021 were placed with order for supply of Diclofenac Sodium tablet 50mg(Coatec) as per rate contract No. 2086 dtd. 25.02.2015, entered into by the firm with the Director, EPM, Odisha, vide this office Purchase Order No.CS15035 Dt. 20.06.2015 The firm supplied film coated tablets instead of enteric coated tablets, which is the official standard of I.P. Accordingly, the firm was asked to replace the stock vide this office letter No. 3650 dtd. 19.10.2015, pursuant to which, the firm took back the entire stock and supplied fresh quantity of the said item in three batches as replacement. On verification, it was observed that the firm had supplied different shape, size and packaged tablets belonging to same batch number and furnished internal test reports, which prima-facie revealed the supplied drugs to be of “Not of Standard Quality”. Hence a show cause notices was issued to the firm vide this office letter No. 289 dt.14.01.2016, asking the firm to show cause as to why they should not be blacklisted for supply of NSQ drugs all the three batches as per clause 7(g)(ii) of above mentioned purchase order.

In their reply, vide letter No. BC/2016/235 dtd.09.02.2016 by M/s. Bubuna Chemicals, the firm have admitted to the charges, which is quoted below:

1. We have committed mistakes while replacing the stock,
2. By mistake, more than 800 boxes of old film coated tablets of different size, have been supplied.
3. We would request you to cancel the purchase order and return the stock.

After careful consideration of the explanation offered by the firm and in accordance with procurement guideline clause 6.1(ii) of OSMCL and clause 7(g)(ii), the undersigned hereby blacklist the firm i.e. M/s. Bubuna Chemicals, D-2/2, New Industrial Estate, Jagatpur-754021. They shall not be allowed to supply this item (i.e. Diclofenac Sodium Tablet 50mg(Coated)) for a period of three (03) successive years from the date of issue of this order.

The performance security/bank guarantee/EMD, if any, submitted by the firm for the said item, is hereby forfeited.


