ORDER

M/s. Eastern Chemical Industries Pvt. Ltd., B-36, Industrial Estate, Cuttack - 753010, were placed with order to supply 1377600 tablets of Diclofenac Sodium (Coated) 50mg as per rate contract no.2086 dt.25.02.2015 of DEPM. Based on such rate contract the firm has been issued with Purchase Order No. CS15024 dt.18.06.2015. The firm supplied the said drug in five batches i.e. batch no. ET15019, ET15020, ET15022, ET15023 and ET15024. Out of same, Batch no. ET15020, ET15022, ET15023 and ET15024 have been found to be of "Not of Standard Quality" on test and analysis by NABL laboratories. The firm has been intimated about the same; vide this office letter no. 755 dt.30.01.2016. The Drugs Inspector has drawn Batch No. ET15020, ET15023 and ET15024 for Test and Analysis and subsequently, all three batches have been declared as "Not of Standard Quality". The firm have also furnished their reply wherein they have mentioned that they are manufacturing enteric coated tablets for the first time and they have sent first batch to NABL Lab. for testing and there by admitting that complete analysis was not done in respect of other batches.

Hence, in accordance with Purchase Order Clause No. 7(g)(ii) and Procurement Guideline Clause No.6.1(ii) of Odisha State Medical Corporation Ltd., the firm is hereby Blacklisted for supplying more than two batches of "Not of Standard Quality" of afore mentioned item. They shall not be allowed to supply the said item for a period of three (03) successive years from the date of issue of this order.

The performance security/bank guarantee/EMD, if any, submitted by the firm for the said item, is hereby forfeited.


