ORDER

M/s. Kingsy Pharmaceutical Works, D-2/6, Mancheswar Industrial Estate, Bhubaneswar-751010, have been placed with the order to supply Diclofenac Sodium tablet 50mg(Coated) based on EPM, Odisha Rate Contract No. 2086 dtd. 25.02.2015, vide Purchase Order No. CS15022 dtd. 18.06.2015. They have executed the order and on test and analysis of the drug, it was found to be enteric coated tablets and of Standard Quality (SQ).

The firm also participated in bid ref. No. OSMCL/2015-16/DRUGS-DHS-CAT VI (Retender)/13 for Metronidazole tablets (Coated) 400mg by claiming to have facility for coating. Based on tender document, the firm have been selected to supply the said item and placed with purchase order no. CR15542 dtd. 19.12.2015.


It has been intimated to this office by the Drugs Controller, Odisha, vide his letter No. 942-C dtd.02.02.2016 that the firm has no facility for coating section of tablets and the firm has not been permitted to manufacture the above drugs (coated).

The firm was required to show cause as to why the firm shall not be blacklisted for such false information and supply of drugs without facility; vide this office letter no. 1397 dtd.17.02.2016. The firm have furnished explanation dated 24.02.2016. They have stated that they have facility to manufacture coated tablets and their coating machine was sent to the workshop for necessary repair work. Subsequently the same has been repaired and reinstalled.

The explanation is devoid of merit and is meant to mislead this office. The firm, M/s. Kingsy Pharmaceutical Works, Bhubaneswar, prima-facie is guilty of violating tender clause No. 6.39.8.3 of aforesaid bid and hence, the firm is hereby blacklisted for supply of the said item (i.e. Metronidazole Tablet (Coated) 400mg). The firm have also violated the Drugs & Cosmetics Act, 1940 and Rules framed thereunder, for manufacturing and supplying Diclofenac Tablets (Coated) 50mg without having facility and permission to do so, as reported by the Drugs Controller, Odisha, and therefore blacklisted for the both the items.

**In accordance with Procurement Guideline Clause 6.1(ii) of OSMCL, since the firm is blacklisted for two(2) items, the firm, i.e. M/s. Kingsy Pharmaceutical Works, Bhubaneswar, is hereby blacklisted. They shall not be allowed to supply any drug to Odisha State Medical Corporation for a period of three(3) successive years from the date of issue of this order.**

The performance security/bank guarantee/EMD, if any, submitted by the firm for the said items, are hereby forfeited.
