The Bidder has submitted the CDSCO online registration screenshot details of Radiographic film instead of the quoted medical device i.e CR Scanner.</li><li>3. The minimum image preview time of the quoted model is greater than 60 secs as per the submitted Product Datasheet which is deviating from the tender technical specification.</li><li>4. The quoted model imager is able to print 65 films/hour instead of at least 70 films/hour for 14" X 17" cassette size as per the submitted Product Datasheet.</li><li>5. The Bidder has not submitted Compliance in required format for provision of Online UPS of suitable rating for back up for 30 minutes power backup for the whole system.</li><li>6. The Bidder has not submitted Compliance in required</li></ol>
