## **INSTRUCTION TO THE CANDIDATE FOR APPEARING QUALIFYING COMPUTER TEST (QCT)**

1. The short-listed candidates are called for Qualifying Computer Test (QCT) in accordance with their merit as per the total weightage obtained taking into account the Career weightage (40%) & CBWT weightage (60%).
2. All candidates must carefully read the below instructions before appearing the Qualifying Computer Test (QCT).
3. The QCT will be held for 60 minutes duration with below schedule:

4. No candidates will be allowed entry into the test centre without valid original ID Proof (Hard copy only, soft copy not accepted) along with one photo copy of the same for submission. Valid ID proof such as Aadhar card / PAN card / Driving License / Passport / Voter ID only.
5. Candidate must bring a coloured passport size photograph with them to submit.
6. Candidates are advised to report the test venue on the reporting time mentioned above. No candidate will be allowed entry after gate closing time, i.e. 15 minutes before the start of the QCT.
7. Candidate should cooperate to ensure smooth security check.
8. No candidates shall be allowed to leave the test hall before completion of the QCT.
9. Candidate must appear the QCT on the date and time mentioned in this notification/instruction. Any request for change of Date/Timing/Centre/Venue will not be entertained.
10. Use of Books, notebooks, calculators, watch calculators, pagers, mobile phones and all types of electronic gadgets etc. are not permitted in the test hall. Candidates are advised not to carry them to the test hall. Candidates will be provided with blank white papers for rough work which will be collected at end of the QCT. Candidates must not copy questions and answers on the papers given for rough work.
11. Any candidates found resorting to any unfair means or malpractice or any misconduct while appearing the QCT including giving/receiving help to /from any candidate during the test will be disqualified
12. Entry of parents inside the test premises is not permitted in any case.
